

ENGLISH

30 x .35g Moisture activated temporary filling (REF 310031)

- 1) Remove cap.
- 2) Place tip into C-R® Syringe.
- 3) Squeeze syringe with a slow, steady pressure and inject into a moist cavity.
- 4) Tamp down with a wet instrument and dismiss patient. On return visit, Tempit®-E may be removed with an explorer.

DEUTSCH

- 1) Rimuovere il tappo.

- 1) Quite la tapa.

- 3) Presione la jeringa con una presión lenta y constante e inyecte dentro de una caries húmeda.
- 4) Apriete el material hacia dentro con un instrumento mojado y deje ir al paciente. En la próxima visita, Tempit®-E puede ser quitado con un explorador.

NEDERLANDS

30 x 0,35g Door vocht geactiveerde tijdelijke vulling (REF 310031)

- 1) Verwijder het dopje.
 - 2) Plaats de punt in de C-R® injectiespuit.
 - 3) Druk langzaam en met gestadige druk op de injectiespuit en injecteer in het vochtige gaatje.
 - 4) Aandrukken met een nat instrument en de patiënt naar huis sturen.
- Bij de volgende visite kan Tempit®-E verwijderd worden met een onderzoekingsinstrument.

SVENSKA

 - 2) För in spetsen i en C-R®-spruta.
