Sodium Carbonate reacts with Fluorine, aluminum, phosphorous pentoxide, sulfuric acid, zinc, lithium, moisture, calcium hydroxide and 2,4,6-trinitrotoluene, and reacts violently with acids to form carbon dioxide. Urea reacts with calcium hypochlorite or sodium hypochlorite to form the explosive nitrogen trichloride. It is incompatible with sodium nitrite, gallium perchlorate, strong oxidizing agents (permanganate, dichromate, nitrate, chlorine), phosphorus pentachloride, nitrosyl perchlorate, titanium tetrachloride, and chromyl chloride.
